# **Author Licencing Agreement**

# **§1**

1. The Author asserts his/her moral and economic right to the Work. The Author declares that he/she holds the moral and economic copyrights to the Work, that these copyrights are not limited within the scope covered by this Agreement, that the Work is a creative, original work, and that the Work does not infringe the moral or economic rights of others.

2. Furthermore, the Author declares that the Work has been created by him/her personally, that it is not an adaptation, a remake or an elaboration of someone else's work, and that until the date of this Agreement, the Work has not been published or distributed.

3. The Author grants the Publisher of "Biuletyn Historii Sztuki", namely The Institute of Art of the Polish Academy of Sciences, with its registered seat at Długa 26/28, 00-950 Warsaw, Poland, a non-exclusive and royalty-free licence to use the Work in accordance with the model licence *Creative Commons Attribution* 4.0 – *International* (CC BY 4.0) <<a href="https://creativecommons.org/licenses/by/4.0/legalcode">https://creativecommons.org/licenses/by/4.0/legalcode</a> or any other language version of this licence or any later version thereof published by Creative Commons.

4. The Author grants the Publisher of "Biuletyn Historii Sztuki" permission to make the Work available to the public in accordance with the model licence *Creative Commons Attribution* 4.0 – *International* (CC BY 4.0) <https://creativecommons.org/licenses/by/4.0/legalcode> or any other language version of this licence or any later version thereof published by Creative Commons.

## **§2**

When sharing the Work elsewhere, the Author is obligated to include full information about the original place of publication thereof.

## **§3**

The Author undertakes to provide the Publisher with the following (if applicable): instructions for illustrating the Work: а selection of illustrations together with information illustrations: about their sources: his/her own the Author's statement on copyright clearance with third parties and on the permission for this material to be used by the Publisher in the fields of exploitation specified in the CC BY 4.0 licence without separate remuneration and without any restrictions.

Should the Publisher make acceptance of the Work conditional upon specific revisions to be made by the Author, the Author is obliged to respond in writing, within 7 (seven) days from receipt of the Publisher's notification, to the effect whether the Author will revise the Work within the timeframe suggested by the Publisher. Failure to respond within the specified period shall be deemed to mean the Author's consent and acceptance.

### **§5**

The Publisher asserts the right to make necessary changes to the Work, as required by editorial processing.

### **§6**

1. The entire Work should be returned with Author's corrections within 10 (ten) days of the receipt of proofs from the Publisher.

2. Failure to return the corrected Work within the above period will be deemed tantamount to the Author's consent to the Work being published in the form sent for correction.

3. The Author is obliged to cover any costs arising from changes being introduced to the Work after the volume is submitted for printing, provided that he/she is culpable for these changes.

### **§**7

This Agreement is concluded in document form; the conclusion is effected upon ticking the relevant checkbox, which indicates the acceptance of the terms and conditions of this Agreement, and upon submitting the Work to the Publisher through the system available at <u>https://czasopisma.ispan.pl/index.php/bhs</u>. Confirmation of the conclusion of the Agreement will be generated by the system and a relevant system notification will be sent to the Author. The aforementioned system is available to users with a registered profile in this system. The registration process involves providing verification data, i.e. the Author's name, surname, e-mail address and ORCID identifier. Should any doubts arise as to the identity of the person submitting the Work to the Publisher, the Publisher asserts the right to perform additional verification, e.g. by contacting the Author by e-mail.

### **§8**

With regard to personal data protection, in fulfilment of the information obligation specified in Article 13 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27th April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC, we inform that the personal data controller is The Institute of Art of the Polish Academy of Sciences in Warsaw, with its registered seat at Długa 26/28, 00-950 Warsaw.
